Use the Social Security Number and date of birth of the first person listed on the 2020 IRS income tax return, and the address on file with the IRS (normally this will be the address used on the 2020 IRS income tax return). In most cases, for electronic filers, a 2020 IRS Tax Return Transcript may be requested from the IRS within 2–3 weeks after the 2020 IRS income tax return has been accepted by the IRS. Generally, for filers of 2020 paper IRS income tax returns, the 2020 IRS Tax Return Transcript may be requested within 8–11 weeks after the 2020 paper IRS income tax return has been received by the IRS.
	If the student and spouse filed separate 2020 IRS income tax returns, 2020 IRS Tax Return Transcripts or 2020 IRS Tax Return must be provided for both.
